
### **UNCTAD's mandate – Trade and Development**


 Focal point for Competition and Consumer Policies within the UN system

> - UN General Assembly Resolution 35/63, 5 December 1980 -


- Recognition of the positive contribution of Competition law and policy to promote economic growth and inclusive sustainable development (greater efficiency and encouragement of innovation).
- "Development dimension": reference to the Preferential or Differential Treatment for developing countries - according to their special circumstances.
- Framework for international cooperation and exchange of best practices.



# UNCTAD recent activities with specific Arab countries

- **MOROCCO**: in cooperation with the Moroccan Competition Council and the World Bank
- Organization of 1 one-day training on Competition for the media (March 2022) and intervention in a Competition workshop for the media held in February 2023.
- Organized and delivered a 3-day training workshop for Moroccan judges (October 2022) on basic aspects of the enforcement and review of Competition law both in the anticompetitive practices and merger fields.
- KUWAIT: UNCTAD intervened in the Kuwait Competition Conference on Promoting Competition Between Challenge and Ambition on the topics of the "Importance of protecting and advocating competition and competition-related subjects and matters" and "Competition Policy and Micro, Small and Medium Enterprises" (December 2022).

#### • EGYPT:

- UNCTAD Regional Training Centre for Competition for the MENA and African countries, hosted and managed by the Egyptian Competition Authority (ECA), UNCTAD has been following up its planned activities in coordination with the ECA.
