# SDG-Climate Security Nexus in the Arab States

### Tuesday 30 March 2021, 11:45 – 13:15 Beirut time (Virtual)

### **Background and objective**

In catalyzing greater levels of water insecurity, reduced agricultural productivity, and fragility of land and ecosystem services, climate change is now increasing social vulnerability, exacerbating conflict and triggering displacement in the region. These climate-related risks are affecting human security, by worsening the conditions of those who are already vulnerable and marginalized. Most of the conflict affected contexts in the region are also some of the world's top climate risk hotspots, with climate-resilient approaches to development becoming increasingly important from both crisis prevention and recovery perspectives. Through a nexus approach, new investments into climate action can bring multiplier effects across SDGs as well as dividends for peace and security.

Objectives:

- 1. Present the impact of climate-security risks as a bottleneck to achieve the SDGs in a resilient manner.
- 2. Present concrete examples of the way in which understanding the climate-security nexus, and mainstreaming those considerations in relevant processes, strategies and policies can have a positive impact on achieving the SDGs in a durable, and riskresilient manner.

#### Questions to be addressed

- 1. How have countries integrated climate-security risks in immediate planning, programming and recovery processes? Where are the opportunities/entry points in the planning/policy-making processes to integrate those considerations?
- 2. What are the regional responses and initiatives addressing climate-security?
- 3. Where will the necessary resources required for an integrated approach come from, and who are some of the main players?
